The COUNCIL will exercise the legislative power of the city government. It will adopt all ordinances, resolutions, be responsible for the approval of the city budget, establishment of financial controls, and the fixing of salaries of all elective and appointive officers and employees. It will render advice and consent with respect to the Mayor's appointments.

# (2) LEO P. CARLIN

Age 45. Attended St. Benedict's Preparatory School. Elected President of Local 478, Teamsters & Chauffeurs Union from 1933 to January 1, 1954. Member of General Assembly 1936. Director of Public Works from 1949 to 1953. Mayor of City from 1953 to date. Married, father of five children.

- As soon effer the election as convenient, the Mayor and the newly elected Council shall meet to study and make plans. Any legal questions arising should be resolved by seeking a declaratory judgment. Preparations should be made to have all ordinances and resolutions necessary for an orderly transition ready before July 1st.
- The Board should have an enlarged staff. The staff should prepare a long-range plan and should actively promote civic development. It should also prepare a capital improvement budget.
- 3. The assessment of property should be administered by a trained professional assessor. A survey should be made to equalize assessments within the city and steps should be taken to insure that Newark's assessments compare favorably with assessments made throughout the rest of the State.

# (3) PEARCE R. FRANKLIN

A Newarker all his life, 62
years. Lawyer since 1916.
Served in Assembly 1921-22.
City Commissioner 1933 to
1941. Wen national commendation for administration of

- Immediately seek cooperation of the elected councilmen to prepare in advance for the introduction of municipal legislation, establishing new departments and assigning governmental functions. In addition, I will give careful consideration to the appointment of key department heads so they can be submitted to the council at its first meeting.
- 2. Under the new form of government the Central Planning Board will take on new importance, working with the Mayor in developing his program for long-range improvements. I propose to include in the Planning Board membership a trained engineer, an architect, a representative of organized labor and trained educators.
- 3. Revaluation of all property to increase city ratables and spread the tax burden more equitably, to relieve small property owners particularly. A long range program to attract new industry, which with more efficient administration should also reduce the tax rate and revitalize the city's economy.

# (1) RALPH A. VILLANI

Age 52. Former Mayor and Director of Parks and Public Property. Received Law degree from Syracuse University 1924. Police Court Judge 1933-1937. Elected to City Commission 1941, 1945 and 1949. Long active in civic and fraternal affairs.

- This change in local government is not a revolution in our municipal affairs. We have an efficient corps of municipal employees who are performing essential services for the city. As Mayor I would most certainly call on the skill and experience of department heads and key workers to effect a smooth change-over.
- Any proposals for a strengthening of the powers of the Planning Board would have to come from the state legislature. I would give any recommendations made by the legislature the most careful consideration.
- 3. During the City Commission campaign last spring I outlined on numerous occasions my proposals for a sound tax program. I have consistently advocated a program of revaluation of properties and equitable reassessment so that the tax burden will be equalised.
