VOTE TO FIGHT "BLIGHT" CASE BEFORE U.S. SUPREME COURT IN WASHINGTON, D.C.

Newark - The Save Our Homes Committee of the CHNC has voted to support the plaintiffs in the light industrial "blight" case in carrying their suit to the US Supreme Court.

The 7 plaintiffs have agreed to go on to the highest court in the land in their quest for justice. Plaintiffs are Mr. and Mrs. C. Webster, Mr. and Mrs. A. Frazier, Mrs. M. Lyons, and Mr. and Mrs. S. Winters.

The group acted after the NJ Supreme Ct. refused to rule on the case and thereby upheld the judgment against them by the Appellate Division last winter.

Plaintiffs allege that 1) the city acted unfairly at its June 1961 hearing when it asked for a "blight" declaration on a 74block area in Clinton Hill and the Central Ward where 18,000 people live; 2) city failed to follow procedures set forth in NJ law for such "blight" hearings. 3) City and Newark Housing Authority did not in fact prove that the area was "blighted"; 4)Plaintiffs were denied due process because of the nature of the hearing.

100 PICKETS AT 5th PRECINCT

A well-organized picket line of over 100 persons, mainly from Clinton Hill, filed past 5th Precinct HQ on Monday, June 29, to demand changes in local police procedures.

The line was initiated after police had made insulting remarks to local residents and ticketed a double-parked car belonging to C. Adams, 716 Hunterdon St., but ignored other double-parked cars belonging to cops.

Pickets asked for an end to double-parking; a play street; removal of abandoned cars;

No ice cream trucks after 10 p.m.; courtoward residents; equal law enforcement. A delegat ion of pickets met with Capt. Max Steinberg to make these demands. Residents are watching to see if the police take

action and the situation improves.

A CITIZEN-GIVEAWAY

(An editorial)

While our neighborhood and others cry for decent public schools, a scrap of park and play space, and better sanitation and other services, the giveaway of the city's valuable downtown land goes on.

It takes years to get one-side-of-the street parking. It takes years for Clinton Ave. merchants to get new parking signs and better lights.

But it takes just a few weeks for Sears Roebuck to get a whole street turned over to it for expansion below Elizabeth Ave.

It takes a few days for an auto dealer to get 12 whole acres around Washington and West Kinney Streets at a write-down cost subsidized by citizens.

Meanwhile, what of the low-income people who were thrown out of that area? They now live in basements, attics, and storefronts. They nowpay higher rents than before.

How long will this giveaway go on?
The daily press backs it because it's getting its share. The Ledger is expanding on urban renewal land; The News just got a zoning variance for expansion in back of Market Street.

Public elected officials have a responsibility to <u>all</u> citizens, not just big business interests. But the citizens must constantly remind them of that.

Always interested in bettering Newark's often not-so-hot schools, the CHNC has voted to affiliate with the new Newark Citizens Committee for Better Public Schools. The 9th annual conference of the CHNC was held on June 7 at Clinton Ave. Presbyterian Church. About 75 persons attended.

The Conference discussed "Jobs, Unemployment, and Civil Rights." Chairman was Mrs. Gladys Washington of S. 14 St.

The Conference approved 3 resolutions which it asked the CHNC Assembly to act upon. They were:

a) Set up a Council ad hoc Employment Committee to enlist jobless people into the council and work for more jobs and job retraining;

b) Set up an Educational Policies Committee to get expert study of the Newark public schools;

c) Ask the Bd. of Education for a large-scale attack on school problems through smaller classes, after-school and remedial work, new schools, and eliminating de facto school segregation.

The Conference heard Stanley Aronowitz, chairman of the Natl Committee for Full Employment, report that 2 million factory jobs a year were being eliminated and that new jobs were not taking up the slack.

"Men are working more and taking home

less than 3-5 years ago," Aronowitz said.
This pay-cut imperils neighborhood
maintenance and civic interest, he said.

Office workers will also be hit, he predicted, and even a high-school education is no guarantee any more.

The solutions he suggested were 1)expand service centers for young people seeking jobs; 2) get the government to create new jobs; 3) mass public pressure.

New jobs, Aronowitz said, should include building new schools, new housing for low and low-middle income families, and better community facilities and services.

"If we don't solve the job crisis," he said, "it will be more and more difficult to keep up our present public facilities." He urged that existing programs be fully utilized and new ones explored.

Kenneth Cibson, Housing Authority engineer also spoke. Mrs. Rose Heyman, CHNC president, brought greetings to the conference.

The conference gave an ovation to Mrs. Elsie Layton for her efforts as hospitality chairman. Mrs. Louise Patterson and Stanley B. Winters, council vice-presidents, helped summarize the discussions.
