

As the rent strike at Stella Wright Homes begins its 34th month there will be Action on High Street.



1) Wednesday, January 3, 1973, - 9:00 a.m., Essex County Court House, 10th floor, Toby Henry, President, Stella Wright Tenant Association and (Rev.) Thomas Comerford will be sentenced by Judge Irwin Kimmelman of contempt of court.

Max .: 6 months and \$1000.00 fine.

2) Friday, January 5, 1973 - same time, same place, same Judge.

- a) 3 lawyers from Essex County Law Reform Project, Harris David, Gerard Clark and Michael Callan, who represented Stella Wright tenants will be tried on contempt of court charge. Max.: Disbarment or suspension, fine.
 - b) Stella Wright Tenants who received money back from fund are ordered to return it to court on this day or face contempt of court charge.

- 1) Citizens Inspection Day, December 16th, was very successful.
 100 people representing 20 different organizations inspected Stella Wright Project and united to plan support actions.
- A committee was formed headed by Bishop John Dougherty, Msgr. Thomas Fahy, President, Seton Hall University and Rev. Paul Stagg, General Secretary to N. J. Council of Churches which will meet December 27th to plan further actions. e.g. a) Delegation to Washington, to City Fathers in Newark.

- b) Educational and Organizational mass meetings at Seton Hall University in near future.
- There was a beautiful turnout in Court on December 18th, both tenants of Stella Wright and supporters.

- 1) Come to Court on January 3rd and January 5th. It is most important that the courtroom is filled and overflowing, and that there are many white faces supporting the tenants and their lawyers. Your presence does make a difference.
