PROGRAM ACCOMPLISHMENTS

a casa de Don Pedro, Inc., organized in 1971, is now the largest Hispanic community-based agency in New Jersey. La Casa's comprehensive network of services helps to develop self-sufficiency and resourcefulness in the citizens of our community. This past year more than 5,600 individuals benefitted from our services.

The following programs are offered by La Casa.

CHILD CARE: 102 children were enrolled in our bilingual program which promotes active parent participation.

LATCH KEY: Educational and recreational activities were combined to offer 35 elementary schoool age children a safe after school environment.

GENERAL AFTER SCHOOL: Through tutoring, recreational activities and individual/group counseling sessions, 150 youngsters, 7-17 years old, learned to overcome educational/emotional difficulties.

TRUANCY PREVENTION: Complements the General After School Program by specifically targeting school truancy problems.

YOUTH LEADERSHIP ACADEMY: Through working outdoor retreats in cooperation with other agencies, leadership skills were taught, to youngsters age 14-17 years old.

TRANSITIONAL/HOST HOME: 101 DYFS-referred boys were helped by our crisis-intervention program with the treatment goal of family-reunification.

FAMILY COUNSELING: Individuals and families received up to one year of either individual or group therapy.

ALCOHOL AND SUBSTANCE ABUSE: Information on prevention and rehabilitation was supplied through educational presentations.

VICTIMS OF CRIME ASSISTANCE: Recent crime victims were counseled and received information on legal and public assistance resources.

CREATIVE PARENTING: Offered parents training workshops on prevention of child abuse and neglect.

EMPLOYMENT & TRAINING DEVELOPMENT: Provided job placements, employment status follow-up and vocational training in collaboration with Essex County Vocational School.

he ability of the non-profit community based sector in New Jersey to survive through the recent economic down turns has been severely tested. Private funding has been curtailed and all levels of public contracts continue to be drastically reduced to meet huge municipal, county and state deficits.

La Casa de Don Pedro, Inc. however, with the support of our sponsors and volunteer Board of Trustees, has been able to develop contingency plans for the present economic obstacles. Furthermore, La Casa's dedicated, creative and generous staff has successfully implemented self-imposed spending reduction measures to deal with expected cutbacks. It is with great enthusiasm that La Casa continues serving our community to achieve the high goals of our mission. It is with great confidence in our abilities to tackle new challenges that we anticipate an even brighter future. COMPUTER EDUCATIONAL CENTER: Computer literacy, basic skills, ESL and homework assistance were offered to all ages.

NORTH JERSEY HISPANIC WOMEN RESOURCE CENTER: Makes available direct and support services to all Essex, Hudson and Union County Latinas.

SENIOR CITIZENS: 280 Seniors participated in this multifaceted program which also provides transportation and a nutrition site.


HOUSING COUNSELING: Assisted in locating rental housing, learn home management and tenant-landlord relationships skills, and offered the SHARE food co-op program.

WEATHERIZATION ASSISTANCE: 980 low-income Essex County residents were provided with energy-conservation measures for their homes or apartments.

HISPANIC LEADERSHIP OPPORTUNITY PROGRAM: Funded by the Ford Foundation, this program has trained 126 professionals in leadership skills and public policy to serve on Boards and Commissions. To date, 55% of the graduates are serving on Boards.

HOUSING DEVELOPMENT PROGRAM: 216 intakes resulted in 29 mortgages processed for our current affordable housing project Villa Santa Maria Townhouses - 39 three and four bedroom units for low and moderate income families.

Our first project, Prospect Gardens Condominiums, completed in 1988, consists of seven one and three bedroom apartments.



Note:

About one third of the figures for direct services represent families, thus the total number of individuals served would be considerably higher. This is also true in all of the weatherization figures, where the data represents only the head of the household, not the number of people living in the apartment.

La Casa de Don Pedro, Inc. owns four of its five facilitas all situated in Newark's North Ward.

LA CASA CREDIT UNION: 660 members received 6.25% return on their accounts; can apply for low interest loans, cash their checks, purchase money orders and receive budget management information. The credit union has an asset base of over \$600,000 and has extended more than a million dollars in loans.
